SUMMARY OF DUTIES AND RESPONSIBILITIES

To provide TA support for the Fall 2025 section of TCA210: Introduction to the Human Dimensions of Climate Change, which is a core course in the Transformative Climate Action Certificate program. TA support will include facilitating weekly synchronous tutorials and/or online discussions, as well as some grading. TCA 210 examines a range of understandings of and approaches to addressing climate change, exploring: what kind of problem(s) it poses; what toolkits we need to develop to engage it effectively; how to collaborate across diverse understandings of and priorities in relation to it and what scales and kinds of actions should be prioritized.
